

# MINUTES GLENVIEW NATURAL RESOURCES COMMISSION February 13, 2012

# 1. Call to Order by the Chairman

The February 13, 2012 meeting of the Glenview Historic Preservation Commission was called to order by Chairman Silver at 7:37 p.m. in the Village Hall Lunch Room.

The December 20, 2011 TRIB LOCAL newspaper printed an article in response to a Village press release regarding the availability of the one dollar house at 8 Park Drive.

Mr. Jeff Rogers said The New Church has made multiple requests for permission to demolition 8 Park Drive. The most recent petition was received on January 20, 2012 and sites specific reasons for this request including on-going maintenance and issues with securing this property. In response to this letter the Village Manager has agreed to allow the Church to pursue a demolition permit. An application has not yet been received.
