#### **OLD BUSINESS**

• Discussion of Single-Family Residence "Birthday" Mailer

Ms. House referenced the latest copy of the birthday mailer that was printed on the card stock that would be used for card mailing. Comments/corrections made were:

# **NEW BUSINESS**

• Recommendation of Rebecca Hunter for Historic Kit Home Recognition Survey

Ms. House summarized that one item included in the plan of action was to conduct another survey. Staff had previously considered a survey of historic kit homes in the downtown area. They had identified Rebecca Hunter who had the historical knowledge of kit homes and their identification characteristics. Staff would like to contract Ms. Hunter to conduct the kit home survey in an amount not to exceed \$5,950. Contracted amount would include field work, draft survey documents, presentations and attendance at public open house and HPC meetings, and final report of all kit homes in downtown area.

## Comments made were:

- HPC was in agreement with scope of work
- Commissioner McWilliams clarified that staff had some information of existing kit homes. Ms. House mentioned that Ms. Hunter would "ride a bicycle" for a closer look in the designated area. Ms. Hunter was familiar with characteristics of kit homes and could identify homes that were not yet known.
- Ms. Hunter would also meet with homeowners, enter and document specific kit home characteristics.
- Commissioner McWilliams confirmed with staff that the amount designated for the survey was included in the 2018 budget.

There were no other comments.

Commissioner Reynolds moved to approve the historic kit homes survey as presented. Commissioner McWilliams seconded the motion. Upon roll call, vote was: AYES: Commissioners Jung, McWilliams, Reynolds, and Tracy
