NOTICE OF CONTINUED HEARING

Please take notice that on Monday, February 15, 2021 at 8:00 A.M., a public hearing will be held before the Glenview Firefighters' Pension Board *via videoconference*, regarding the disability claim of the above Applicant, pursuant to the applicable provisions of Article 4 of the Illinois Pension Code.

The President of the Glenview Firefighters' Pension Board finds that an in person meeting is not practical or prudent and that in person attendance by one of the Pension Board Trustees at the Fire Department is not feasible due the coronavirus and the Governor's Disaster Proclamation.

The public hearing will be held to receive evidence concerning the disability application of the above Applicant. The Applicant and Intervenor are entitled to be represented by legal counsel, to present any evidence and to respond to any evidence before the Board.

The public hearing is being held via videoconference without the requirement of in-person attendance in accordance with Governor Pritzker's Executive Order. Public comment will be held during the meeting and will be limited to 5 minutes per person.

The Pension Board may adjourn to Executive or Closed Session, pursuant to §2(c)(4) of the Open Meetings Act, for purposes of deliberations, upon completion of the evidentiary hearing. No final action will be taken in Executive/Closed Session.


