Last chances to register: Voters must sign up by Oct. 9

Voter registration is open Monday through Friday, 9am to 5pm, at the Village Hall (upper level), township offices and the County Clerk's office in Chicago. **The last day to register at any of these places is Monday, October 1.**

The Northfield Township office is at 3800 West Lake Avenue (northwest corner of Lake and Pfingsten Road). It is open from 9am to 5pm Monday through Friday, **and from 9am to noon on Saturday.** (If you live in Maine Township call 297-2510; in New Trier Township the number is 446-8200; in Niles Township, 673-9300.) The County Clerk's office in Chicago is also open Saturdays, 9am to noon.

Registration will be held in all Glenview polling places on Tuesday, October 9, from 8am to 9pm. Election day is Tuesday, November 6.

In order to register and vote you must be a citizen of the U.S., 18 years old (by November 6), and registered at your current address.

TO REGISTER: Bring two valid identification documents (such as an Illinois driver's license, Social Security card, utility bill, employee or student ID, major credit card, union or professional association card), **one of which includes your current address.** Naturalized citizens should also bring citizenship papers, or know the court and the exact date of naturalization.

Registered voters who have moved within the village of Glenview, or into Glenview from elsewhere in suburban Cook County, must transfer registrations to their current addresses by filling out the backs of Verification of Voter Registration cards and mailing them to the Cook County Clerk. Registered voters who have moved into Glenview from Chicago or outside Cook County **must reregister.**

Registered voters who will be absent from the county on Election Day (Tuesday, November 6), may vote by Absentee Ballot, either in person or by mail. **Absentee voting by mail is open from September 27 through November 1.** Call the County Clerk's office, 443-5150, **before September 27** to apply for absentee voting by mail.

In-person absentee voting is open September 27 through November 5 at the County Clerk's office, Room 404, 118 North Clark Street, Chicago (443-5150).

DENNIS GOESSELLE, Glenview's Animal Control Officer, a member of the Glenview Police Department for the past 18 years, died of a heart attack August 20 at the age of 41. He performed outstanding service for the village and the local elementary schools, and will be sorely missed. On behalf of the Glenview community we extend sympathy to his wife and children.

GLENVIEW ROAD IMPROVEMENTS may begin sometime in September at Waukegan Road, working westward. Between Waukegan Road and Lincoln Street, the roadway will be repaved and curbs, gutters and sidewalks replaced. Preliminary plans (subject to change): From Lincoln Street to Shermer Road, pavement will be completely reconstructed. Completion to Milwaukee Avenue is expected sometime in 1985. When finished, there will be sidewalks on both sides of Glenview Road all the way to Milwaukee Avenue, and more than 200 new parkway trees will be planted.

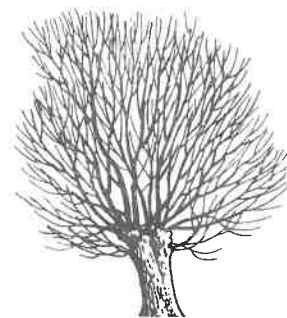
THE 6TH ANNUAL GROVE FOLK FEST will be held Sunday, October 7, from noon to 5pm. Sample pioneer food, watch folk-art demonstrations and Indian entertainers, take a mini-tour of the Kennicott House, and buy handmade crafts. Admission is free except for a parking donation of \$1 per car. Preferred parking at Kennicott House and Redfield Center is available at \$10 per car -- reserve preferred parking in advance at the Park District office, 1930 Prairie Street (checks payable to Glenview Park District).

New plan for planting of parkway trees

Because new plantings of parkway trees have not kept up with tree removals, Glenview has a new parkway tree-planting policy under which the village pays 100% of the cost of new parkway trees. In previous years residents had shared half the cost. (Provision for the new arrangement is part of the 1984 Capital Budget.)

Residents of certain areas will soon receive letters asking whether trees should be installed on the parkway adjacent to their properties and what species from a given list would be preferred.

Because of such considerations as overhead wires, underground utilities, and obstructions in sightlines, the vil-



lage retains the right to the final selection of species in each case.

Village officials estimate that under the revised policy new plantings will exceed removals by approximately 100 per year, and vacant parkways will be planted within seven years.

Added runs now leave the airport at 6:45pm for Glenview, and leave Glenview at 7:15 for Des Plaines. Revised schedules are available from NORTRAN drivers.
