GLENVIEW'S NEW POLICE OFFICERS

Glenview has five new police officers, four of whom are pictured above. Officer Stephen Ballard, in the service during 1970-72, had a 240-hour course with the Army in Law Enforcement, and later worked for a short time with a police department in North Carolina.

Officer Mary Jones is a graduate of the University of Iowa, and taught school for two years while applying to various police departments in the hope of being selected for the police work she has always wanted to do.

Officers Jeffrey Hirsch and Brad Weigel came to the Glenview Police Department in January of 1972 as cadets. Hirsch has studied three years at the University of Illinois, majoring in Criminal Justice. Weigel has two years of Law Enforcement studies at Harper Junior College and the University of Illinois.

Officer David J. van Milligen was finishing work for his Master's Degree in Police Administration at Southern Illinois University as we went to press, and was unavailable to be photographed for this issue.

The five entered the Illinois Police Training Institute at Lisle on September 4 for six weeks of intensive training, and will return to full-time duty at the end of October.

Only two injuries occurred during the year, involving only 16 man days lost — an excellent record for a group of this size, and one significantly better than ours for the previous year.

BABY SITTER ORIENTATION PROGRAM

This fall's Baby Sitter Orientation Program begins Thursday, September 27, for five consecutive Thursdays through October 25, sponsored by the Glenview Fire Department. Classes include training in safety and first aid techniques. Coordinator of the program is Glenview Fire Inspector Philip Guzzetta.

You must be at least 12 years old to register for the program. Boys, girls, and adults are all welcome. There is a one-time fee of 25¢, payable at the first session. Hours are 7 to 8:30 PM, and sessions will be held in Glenview Playdium classrooms, first floor west.

THE GLENVIEW TRUSTEES...

- Passed the Appropriation Ordinance for 1973-74, with a total of \$3,805,936.
- Adopted the 1973 annual property tax levy requirement of \$949,325.
- Authorized participation in a program for state certification of firefighters, under the Illinois Fire Protection and Training Act. (Firefighter recruits will now be required to take and pass a 200-hour training course.)
- Awarded a contract (\$52,459.85) to Weber, Hilmer & Johnson, Inc., for furnishings (furniture, draperies, and carpeting) for the new Police Administration Building.
- Amended the Village Code to allow taxi drivers to work at age 18 instead of the former minimum age of 21, bringing Glenview into accordance with state law requirements.
- Renewed the franchise of Northern Illinois Gas Company for 50 years.
- Signed an agreement with D. Coder Taylor Associates for the design of a Fire Station addition on the site of the present building.
- Amended the traffic code to allow one-hour parking on the north side of Colfax, Waukegan Road to Nottingham.
- Annexed 1707 Kendale Drive.
- Adopted a resolution objecting to the proposed car wash on Kutten Oil property on Laramie Avenue in Wilmette.
- Filed a legal objection to rezoning of one acre on the west side of Milwaukee Avenue northwest of Greenwood Avenue for a motorcycle and sub-compact car dealership.

RESIDENTS OF THE WILLOWS will be interested to know that the emergency water connection between Northfield Woods Water Company and the Village of Northbrook has now been completed. This agreement was negotiated by the Village of Glenview.

ILLINOIS DEPARTMENT OF TRANSPORTATION HEARING

Mayor Patten represented the Village Board at the Illinois Department of Transportation hearing in Park Ridge August 22, stating that Glenview favors creation of a Regional Transit Authority for the six counties of northeastern Illinois, provided that:

- The policy-making body is composed of representatives chosen on the one-man-one-vote principle, so that sub-urban areas will have a fair voice.
- The body be empowered to exercise effective control over transit interfaces so as to achieve meaningful coordination, efficient service, and an integrated transit system.

He stated that Glenview opposes a 5% utility tax as not only burdensome but unfair to those who derive no direct benefit from improved mass transit service, and that Glenview also opposes a parking tax. What we favor, he said, is a combination of half of one percent of the present sales tax and an additional 5% sales tax on gasoline within the six-county area.

PLANT HALF A TREE!

The Village will plant the other half.

There's no season of the year that isn't more enjoyable if you have trees to look at. All summer they have shaded us. Birds like to nest in them and sing in them. Cats like to climb them. Dogs like them too. Children love them. Kites sometimes get caught in them.

But best of all, trees enhance the value of your property. The tree you invest in this fall will reach beautiful maturity in 20 years, and help to keep Glenview beautiful.

So why not plant at least half a tree this fall?

Here's the deal:

The Glenview Public Works Department will furnish and plant a tree on the parkway adjacent to your house, and guarantee it for a whole year. (They reserve the right, of course, to reject unsuitable locations, as maintenance is a Village responsibility.)

You pay only HALF THE COST — the Village pays the other half.

Here are the trees available this year:

Ash, Hackberry, Red Maple, Red Oak, Redmond Linden, and Thornless Honey Locust — all hardy varieties that will last for many, many years to come.

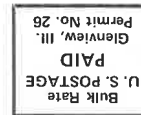

(PS: If you have new sod on your parkway, it is best not to apply this year, as excessive watering is not good for young trees. Water your sod well this fall and next summer, and apply for a tree in the fall of 1974.)
