

July 28, 2020 Glenview Building Commission 11:00 AMVirtual Meeting

This meeting will be conducted by audio or video conference without a physically present quorum of the Building Commission because of a disaster declaration related to COVID-19 and public health concerns affecting the Village of Glenview. The Chairperson of the Building Commission has determined that an in-person meeting at Village Hall is not practical or prudent because of the disaster. The Chairperson and Secretary may be present at Village Hall, but the Building Commission Members and other staff will not be physically present at Village Hall because their attendance is unfeasible due to the disaster. Physical attendance at Village Hall by the public is also not feasible because of the disaster.
