## **Board of Fire and Police Commissioners Agenda for Special Meeting**

This meeting will be conducted in accordance with recent amendments to the Open Meetings Act that allow meetings of a public body to be conducted via audio and/or video conference during a disaster declaration. All or some of the members of the Board of Fire and Police Commissioners (BFPC) will be attending this meeting electronically due to the COVID-19 pandemic and public health concerns affecting the Village of Glenview. The Chairperson of the BFPC has determined that an in-person meeting at Village Hall is not practical or prudent because of the disaster. Physical attendance at Village Hall by the public is also not feasible because of the disaster but can attend the meeting electronically as described below.
