

**SPECIAL MEETING  
VILLAGE OF GLENVIEW  
MINUTES  
BOARD of FIRE and POLICE COMMISSIONERS Meeting  
March 25, 2021**

Assistant Village Manager, Sarah Schillerstrom, called the Board of Fire and Police Commissioners meeting to order at 6:33 PM.

Commissioner Hogan made a motion to begin the open session at 6:33 PM, seconded by Chairperson Cho.

Assistant Village Manager Schillerstrom stated tonight's meeting was conducted in accordance with recent amendments to the Open Meetings Act that allow meetings of a public body to be conducted via audio and/or video conference during a disaster declaration. All or some of the members of the Board of Fire and Police Commissioners attended this meeting electronically due to the COVID-19 pandemic and public health concerns affecting the Village of Glenview. The chairperson of the BFPC has determined that an in-person meeting at Village Hall is not practical or prudent because of the disaster. Physical attendance at Village Hall by the public is also not feasible because of the disaster, but the public can attend the meeting electronically as described in the posted meeting agenda.
